

RELEASE, WAIVER AND HOLD HARMLESS AGREEMENT

THIS AGREEMENT LIMITS LEAGAL LIABILITY, READ IT CAREFULLY

**1. Release in Consideration of Right to Compete.**

In consideration of the acceptance of the undersigned's application to enter and compete in the Miss CCPRA State Rodeo queen Pageant by the Miss CCPRA State Rodeo Queen Pageant Committee, the undersigned does hereby irrevocably **RELEASE** the Miss CCPRA State Rodeo Queen Pageant, there agents, employees, heirs and assigns (hereinafter referred to as the "Pageant") from any and all claims for injury to persons or damage to property which may result directly or indirectly from participation in any event, performance, or other activity associated with the pageant and/or the Coronation at the Finals Rodeo.

**2. Hold Harmless and Waiver Agreement.**

By signing this agreement, the undersigned, for herself, her heirs, executors and administrators, does **WAIVE, RELEASE, DISCHARGE AND HOLD HARMLESS** the pageant from any and all right, claim or liability for damage or for any and all injuries that might be sustained by the undersigned, including injuries to animals, or from any and all claims of any kind or nature resulting from or arising out of the undersigned's participation in any event, performance, or other activity associated with the Pageant and/or the Coronation at the Finals Rodeo.

Further, the undersigned hereby acknowledges that the terms of this **RELEASE, WAIVER, AND HOLD HARMLESS AGREEMENT** will extend to any accidents, damages or claims arising out of the undersigned's participation in any event, performance, or activity associated with the Pageant and/or the Coronation at the Finals Rodeo caused by the acts of the undersigned or the acts of anyone or any animal under the control of the undersigned.

The undersigned further warrants that she is **ASSUMING THE RISK** of any event, performance or activity associated with the Pageant and/or the Coronation at the Finals Rodeo and **WAIVES** any claim she may have as a result of such assumption, known or which may later be known.

The undersigned further does hold the Pageant **HARMLESS** for any claim for negligence by the latter, waiving the provisions of Civil Code §1542.

**3. Agreement to Indemnify and Defend.**

The undersigned agrees that she will **DEFEND, INDEMNIFY, AND HOLD HARMLESS** the Pageant against all claims, demands and cause of action, including court costs and attorney's fees, directly or indirectly arising from the undersigned's participation in any event, performance or activity associated with the Pageant and/or the Coronation at the Finals Rodeo, and/or any action or other proceeding brought by the undersigned or prosecuted for the undersigned's benefit contrary to the terms of this agreement. Said indemnification or defense extends to any claim or action brought by individuals under the undersigned's supervision or control.

**I ACKNOWLEDGE THAT I HAVE READ THE FOREGOING TERMS, KNOW AND UNDERSTAND THE CONTENT THEREOF, AND AGREE TO ABIDE BY SAID TERMS AND CONDITIONS.**
