

Miss CCPRA Statement of Acceptance

Please read the forgoing statements fully and completely. After reading the statement please initial on the line to the left of the statement once it is understood in its entirety. This must be turned in fully completed with the application as a statement of pre-acceptance and will also be provided for signature with the coordinator after coronation.

_____ I understand that I won the title of Miss CCPRA or 1st/2nd Runner-Up. This means that I will be the official representative of the professional sport of rodeo, the California Cowboys Pro Rodeo Association and the cowboys and cowgirls in the true light to the general public.

_____ I will strive to represent unexcelled sportsmanship, high moral and ethical character and humane treatment of animals.

_____ I understand that the Miss CCPRA Pageant was a competition that recognizes a number of attributes: Horsemanship, Personality, Speech, Interview, Impromptu Questions and Appearance. Therefore, it is my responsibility to act, speak and dress according to the esteem my title deserves. Any time that I am in the public eye I will conduct myself with dignity, poise, courtesy at all times.

_____ I understand that riding and horsemanship skills are the key to the promotion of the sport of rodeo. Therefore, I will strive to keep my horsemanship skills in order to better promote the sport of rodeo.

_____ I agree to wear my Miss CCPRA crown, banner, buckle and chaps anytime I am acting in the capacity of Miss CCPRA.

_____ I will avail myself of all opportunities to appear as Miss CCPRA before the public and be prepared for photograph and interview opportunities to promote the professional sport of rodeo and the CCPRA.

_____ I agree to attend as many rodeos as I can that are requested by the Miss CCPRA Pageant Committee.

_____ I understand that I am to provide my own transportation to and from the rodeos.

_____ I understand I must turn in my gas expenses monthly to the Miss CCPRA Coordinator in order to be reimbursed.

_____ I understand that I will use a log sheet to submit my expenses with explanations of rodeos appeared at, dates and if I traveled to an assigned rodeo with a partner or if I competed in a rodeo event.

_____ I understand that in the event I travel to an assigned rodeo with a partner that only one-half of my fuel expenses will be reimbursed.

_____ I understand the log sheet is included in my Queen Binder.

_____ I understand I am only reimbursed for my fuel expenses in the set amount of \$_____. Unless otherwise noted or pre-arranged and agreed upon by the Miss CCPRA Coordinator no motels, food, stalls or personal expenses are covered.

_____ I agree to uphold the title of Miss CCPRA and to encourage other to participate in future pageants, fulfill the provisions of my reign, act as hostess to contestants and spectators at future rodeos and pageants and assist in the promotion and conduct of the pageant in every way.

_____ I agree to be present at the following year's pageant to act as official hostess and at the coronation ceremony in order to crown my successor.

_____ I understand that I am responsible for raising \$_____ as set by the Miss CCPRA Coordinator in sponsorships that need to be turned in and paid for by August 1st of my year of reign to the Miss CCPRA Coordinator.

_____ I understand that I cannot exchange or trade any part of the fuel reimbursement for any part of the sponsorship amount that I am responsible for.

_____ I understand that I need to write a monthly letter/column for the Competitors News and that it must submit it to the CCPRA Secretary by the _____ of every month during my reign.

_____ I understand that I am to be present at the Grand Entry of the rodeos I am attending and to serve as official hostess.

_____ I understand that I am to be available to push calves/steers out of the arena.

_____ I understand that I am **not** to consume alcoholic beverages, smoke, use illegal drugs or non-prescription drugs, use foul language nor wear non-prescribed sunglasses while representing the CCPRA and the Miss CCPRA Pageant.

- _____ I understand that any conduct unbecoming of Miss CCPRA or not fulfilling my duties as Miss CCPRA during my reign will result in the loss of my title and any/all of the items awarded to me as Miss CCPRA.
- _____ I understand and agree that during the term from my entry as a contestant through my reign as Miss CCPRA I shall remain unmarried and non-child bearing and I shall observe the highest standards of moral and ethical behavior
- _____ I understand that I will only get two warnings during my reign of any unbecoming conduct. However, the situation will be thoroughly investigated.
- _____ I understand that I am responsible for my own wardrobe.
- _____ I understand that my official appearances must be approved by the Miss CCPRA Pageant Committee and I agree to maintain close contact with the Miss CCPRA Coordinator to accomplish this.
- _____ I understand that if something prohibits me from making an appearance I may call upon the 1st or 2nd Runner-Up unless pre-arranged and cleared by the Miss CCPRA Coordinator.
- _____ I will make myself available upon the request of the Miss CCPRA Coordinator, if possible, and if I am unavailable I will find a replacement for that event.

_____ I understand that developing and maintaining a relationship with the Miss CCPRA Coordinator will be invaluable during my reign.

_____ I have an understanding of what is expected of me but if I am unsure or don't understand an issue I agree to call the Miss CCPRA Coordinator and discuss the matter.

_____ I agree to be honest with the Miss CCPRA Coordinator and contact her if I am unable to juggle a rodeo and/or another event.

_____ I understand that with a "CAN DO!" attitude and I am up front with everyone involved during my reign it will be a time in my life when doors are opened for future opportunities and memories.

_____ I understand if I need help or support to call the Miss CCPRA Coordinator.

_____ I agree that I have received a Miss CCPRA binder with helpful hints, tips, dates of various events and contact information. This will help in guidance with how and where to start my reign.

_____ I know who the Miss CCPRA Coordinator is. She is:

_____ I understand that I must be eligible for the Miss CCPRA Scholarship. I must be enrolled as a student with any educational institute in order for me to accept the Scholarship.

_____ I understand that I must provide the name of the school that I am attending as well as written proof in current enrollment with either a current transcript or official registration of classes with any educational institute such as a University, State college, Junior College, Mechanic School, Technician School, Trade School, Cosmetology School, Certification Program, etc.

_____ I understand that I must submit my request for the Miss CCPRA Scholarship during my reign and be enrolled at an educational institute of my choice.

_____ I understand that I cannot trade any portion of the Miss CCPRA Scholarship for any amount that is required by me in sponsorships.
